Motion by K.F. to appoint Lisa Mastros as a Community Member Representative. Seconded by J.L. and carried unanimously. Motion by K.F. to appoint Amy Nelson as a Parent Representative. Seconded by J.L. and carried unanimously. Ms. Mastros and Ms. Nelson will be sworn in at the next meeting.

6.2. Discussion and Possible Action Regarding Governance Training Proposal with TCM Consulting

TCM Consulting services provides professional development on CC boards, explains roles and responsibilities, objectives, and evaluation tools. Does trainings on bylaws, The Brown Act, and Governance Structure. Can be done virtually or in person. E.S. researched other companies but TCM was the most cost effective. Proposal of personal development sessions is 3 sessions of 3 hour workshops for the CC board and E.S. receive coaching up to \$4,500 max. T.M. abstained from voting as he is stepping down from the council. Motion by L.S. Seconded by K.F. and carried unanimously.

- **6.3.** Discussion Regarding Staffing for the 2020/2021 School Year
 - Choir & Art teachers will provide video lessons and attend some Zoom meetings
 - Classroom teachers will have 10 hours of aide support
 - Reading teacher will have 10 hours a week to support struggling students
 - Position of Intervention Support Teacher will be added through November 20th
 - ELD Coordinator will have 15 hours a week to support EL students No action required.
- 6.4. Discussion Regarding Re-opening plan.

 - Draft of Learning Continuity and Attendance Plan (Due Sept 30) was shared
 - Comparison LCAP and Learning Continuity and Attendance Plan was shared No action required.
- **6.5.** Discussion and Possible Resolution Regarding administrator's recommendation to start the school year with 100% distance learning per Dr. Doohan's 7-15-2020 statement.

Resolution 7232020 R1 was read. There was a motion by J.L. Second L.S., carried unanimously.

6.6. Discussion and Possible Action Regarding facility work, including possible approval of Polished Concrete Concepts quote to polish large commons floor.

A. Custodian 15 hours per week, can be assigned to help beautify the school with jobs such as but not limited to: drywall repair, paint walls, clean carpets. Good opportunity to do this while students are not on campus. No motion required.

B. Proposal of the company Polished Concrete Concepts to grind and polish the common area's floor. If school likes the results there can be further discussion on redoing the hallways. CC board discussed how long the grinding and polishing would last, if there was any potential it could be chipped, how to clean it, and if polishing would make it slippery. E.S. believes the floor will last many years but will ask the company. Company (PCC) did Raley's grocery store's floors and there is a minimal chance of slipping, wear from student activities, or potential for chipping. Council discussed placing carpet mats near entry ways for students to wipe their feet. Proposal of \$7,144 to grind and polish common area's floor. Motion by J.L. Seconded by L.S. and carried unanimously.

C. Discussion regarding asking parents for donations to beautify the school. Good opportunity to do projects while students are not on campus. No action at this time.
