A family survey was implemented to find out what options would work best for the plan. Teachers were surveyed to find out what needs their students

have, and what they'd be willing to teach in the summers. School staff was asked to consider the needs of the students and brainstorm supports to meet those needs.

Draft goals were shared with the faculty council, parent council, and charter council. Public meeting was held on DRAFT LCAP. It was shared with the community and all stakeholder groups for review.

Student needs were identified based on a combination of data review and teacher recommendation. Star Reading and Star Math data were examined for analyzing the learning gaps and to inform instruction.

This plan was solely influenced by community input. Families at ROCS have been involved with the development of the LCAP, which is directly aligned with and enhanced by ESSER III funding.

- 1. Ensuring access to interventions to mitigate learning loss are available to assist struggling students, students with disabilities, and English Learners;**
- 2. Providing students with access to educational technology to maximize learning opportunities;**
- 3. Providing students access to mental health services and supports;**
- 4. Improving indoor air quality in the classrooms;**
- 5. Repairing/improving the school facility to reduce the risk of virus transmission and exposure to environmental health hazards;**
- 6. Ensuring the LEA continues to do what is necessary to maintain operations and continuity of services and continuing to employ existing staff.**

River Oak Charter School coordinated the use of the ESSER funds by budgeting all funding sources across several categories to best meet the needs of the school staff, teachers, students, and community.

In 2021-22, the ESSER funds are primarily budgeted for mental health services, counseling supports, supplemental instruction such as after school tutoring, additional academic services such as diagnostic, progress monitoring, and benchmark assessments, and professional development including trauma informed practices, to engage students and families in students' social emotional health, before and after school programs, COVID-19 testing costs, and personal protective equipment, sanitation supplies, HVAC system upgrade, furniture and facility changes to allow healthy attendance and more outdoor classroom opportunities. Additional independent study teaching time and/or substitute teachers to allow meaningful assignment development and interaction is included in the plan.

Then, in 2022-23, the ESSER funds are primarily budgeted for additional remediation/intervention services, after-school tutoring, and mental health services.

The administrator, as well as teachers and school staff, are available to talk with families each day and from these informal connections,

we are able to gather feedback and plan. At ROCS, multiple perspectives are valued when making decisions.

ESSER III Expenditure Plan Instructions

Introduction

School districts, county offices of education (COEs), or charter schools, collectively known as local educational agencies (LEAs), that receive Elementary and Secondary School Emergency Relief (ESSER) funds under the American Rescue Plan (ARP) Act, referred to as ESSER III funds, are required to develop a plan for how they will use ESSER III funds to, at a minimum, address students' academic, social, emotional, and mental health needs, as well as the opportunity gaps that existed before, and were exacerbated by, the COVID-19 pandemic.

The plan must be adopted by the local governing board or body of the LEA at a public meeting on or before October 29, 2021 and must be submitted for review and approval within five days of adoption. - **Tier 4 – Demonstrates a Rationale:** practices that have a well-defined logic model or theory of action, are supported by research, and have some effort underway by a State Educational Agency, LEA, or outside research organization to determine their effectiveness.
